SUPERINTENDENT CONTRACT: Motion by Marcy Roeber, seconded by Kari Rohde to approve the rehiring of Michael Pattee as the Superintendent for Allen Consolidated Schools for the 2026-2027 school year. MCU 5 – 0

PRINCIPAL CONTRACT: Motion by Lane Anderson, seconded by Dawn Oswald to approve the hiring of Christopher Blohm as the Principal for Allen Consolidated Schools for the 2026-2027 school year. MCU 5 – 0

2026-2027 NEGOTIATED AGREEMENT: Motion by Lane Anderson, seconded by Kari Rohde to approve the Negotiated Agreement for the 2026-2027 school year. MCU 5 – 0 The agreement includes:

- Increase dental health insurance coverage provided by the school for Family, Employee Spouse, Employee Children to 100%.
- Adjust sick and personal days from 9 sick and 3 personal to 8 sick and 4 personal.
- Increase the base salary by \$450 (Four Hundred and Fifty Dollars).
- Added and updated language in Article I, Section VI clarifying when teachers are paid for covering classes.

The Allen School District will pay \$25.00 to a certified staff member when they are asked to cover a class that is not part of their regularly scheduled day. Definition of a class period for secondary is a 50-minute block of time and for elementary is a 25-minute block of time. In the case of shortened days, a class period would be defined as the length of time that is allotted for a single secondary class within the schedule for the day.

Examples include but are not limited to the following:

- If a teacher has a plan or free schedule in their day and they are asked to substitute during that time.
- If a teacher has to disrupt their regularly scheduled class time to cover multiple classes
  - Example - Teacher is asked to take study hall students in addition to teaching their regularly scheduled class.
- If an elementary teacher is asked to combine two classes to cover for the absence of another teacher.
- If a specials teacher is gone and they cannot make up the missed time within a week of being gone.

Examples not included are the following:

- A study hall teacher is asked to combine two study halls into one
- A teacher that has the flexibility to substitute in another classroom (as long as they still have the schedule plan time of the teacher they are subbing for).
  - Examples—Title teacher, librarian, guidance teachers.
- If a specials teacher is gone, they are able to make up the lost time for the classroom teacher within a week of the absence.
- If a teacher has a regularly scheduled class, but no one is in that class due to a school wide program (Fridays at Northeast or school activities).

- This is a 3.94% increase to the overall operating budget for Allen Consolidated Schools.
